	Applying for this grant is a public school, public school district, or ISD. (Private not eligible)
	Applicant has received a FREE safety assessment, or is not applying for reimbursement of one. (If received an assessment from a West Michigan Glass Coatings, YES.)
	Safety & security window film quote includes security film which meets ANSI Z97.1-2015, EN 356, EN 12600, UL 972, ULC 332, or similar standards. (If received a quote from a West Michigan Glass Coatings, YES.)
	Safety & security window film quote includes an attachment system. (If received a quote from a West Michigan Glass Coatings, YES.)
	All priority glass that has been quoted is located on the exterior envelope of the building. (If received a quote from a West Michigan Glass Coatings, YES.)
	Per building quote does not exceed \$50,000. (If applying for multiple safety projects, each building must stay below the \$50,000 threshold).
	Applicant demonstrates proof that school has an Emergency Operations Plan for each school building that aligns with the state of Michigan EOP guidance and school safety policy developed under MCL 380.1308 and has been updated since August 1, 2017.
	School is compliant with MCL 380.1308b (2018 PA 436) by providing notice via MEGS+ to the Michigan Department of their completed Emergency Operation Plan adoption/review for all school buildings identified in application no later than 1/31/20. (Questions? Email: msp-schoolsafety.gov)
	School is compliant in incident reporting requirements with MCL 380.1308a (2018 PA 551) including filing reports within 24hours after an incident occurs. (Questions? Email: msp-schoolsafety.gov)
